



LYSA Membership Meeting Call to Order: A combined meeting of the LYSA Membership and Board was held on August 11, 2020 at the Lake Yosemite Sailing Association Clubhouse. The meeting convened at 7 pm, Commodore George Deane presiding.

Reports - Actions - Discussions: Commodore, George **Deane:** George welcomed members to the meeting. George invited Board / Committee Members to report. **Approval of Minutes:** July minutes approved by acclimation.

Commodore, George Deane: Discussion of lease. Discussed raising dock fees to cover repairs / maintenance and \$3K deficit. It's been about 10 years since we've had an increase in dock fees. George confirmed the insurance policy complies with their needs.

Lease with the County is due in 2022. According to the lease the County will pay for the house roof, electrical and plumbing, anything else we need permission. Discussion of improvement to include water heater. George proposes a letter be written to MID asking approval to pour the slab. Would like to incorporate water heater and rent offset in the letter.

Vice Commodore, Dennis Pellissier: Not present. George shared that if anyone backs into the fence, they will be

asked to pay to repair it. Dennis did a closer survey of the fence. The bad posts are repaired.

Treasurer, Diane Sousa: No report. Racing fee report given to Rachel.

Dock Captain, Kendall Nightengale: Work completed earlier in the year, not much activity recently. Idea: online form to report dock issues, Kendall asked if Members would use such a form. This would help identify future needs. Rachel suggested notifying / informing Members in the Newsletter before the form is posted.

House Captain, Deb Harden: Tim Ledford will be calling Deb to sign the contract to schedule to have the concrete slab poured in the kayak shack. Racks will be built for the kayaks. LYSA kayaks are labeled with LYSA. Discussed charging a nominal fee for kayak storage. Everything is fine with the house.

People have been making reservations for the house, we need to comply with Covid-19 guidelines (no more than 10 people, masks, etc.). Instead of using the house, Peg and John borrowed chairs.

**Cruise / Social Committee, Mike Strealy:** Not present. Deb shared Mike's report: he is not planning any events until 2021. No Christmas party or any events. Diane suggested Mike continue his role next year. Gary asked if we are able to come to the Lake during weekends. Jay suggested it would be bad form to use the Lake. Rachel was told to leave, they called Bryan from Parks & Rec and he said no. The County really doesn't want us out here. They are having huge issues on the back side of the lake with people and cars all the way down the street.
